Update from City Hall

As the year winds down, City Council looks back and forward. This year has been challenging as the city has endured the economic recession with the rest of the state and country. While the city remains fiscally stable due to good financial policies and budgetary adjustments, Council will approach the **2010 budget ordinance** anticipating a slow turn around in the economy as well as increasing costs. The budget ordinance will receive three readings and have a public hearing before the end of the year, as Council meets in November work sessions to discuss it.

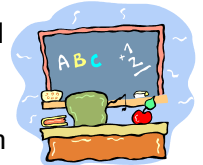
Council adopted an ordinance last month levying an **annual motor vehicle license tax of five dollars per vehicle** for all vehicles registered in Tallmadge. This new tax will not go into effect until **January 2011**. All income generated will go toward road paving. In 2009 all re-paving was cut from the budget due to decreased revenues and budget cuts.

Council also adopted Ordinance 120-2009 that **freezes salaries and wages for all elected officials in the city as well as non-bargaining employees for next year**. An ordinance to create a voluntary retirement incentive program for eligible employees was also adopted, thus further decreasing the city payroll.

Despite streamlining the number of employees in the city, Council and the city administration intend to maintain the quality of services to the citizens of Tallmadge. Along that line, the **leaf pick up program will begin near the end of October**. Our streets will be plowed and salted, although the **free driveway plow for seniors will be suspended**. Joining dispatching services with Stow and Mogadore have continued to serve the city well, while providing savings to the city. Of course, the **annual street dance** outside the Rec Center, including hotdogs, donuts and cider will be **Thursday, October 29**, after trick or treating. See you there.

Board of Education Update

At the September 16th Board of Education Meeting, an **independent review panel** presented its report to the Board regarding the need for the levy which will be on the November 3rd ballot. In part, the panel's review *"found the school system to be good financial managers of the taxpayer's funds. They have reduced expenses in a declining revenue environment while increasing student performance to the highest standard set by the State of Ohio. They have done this without any additional funds from the citizens for 9 years. There is truly a need for the requested 6.9 mill levy and we urge the citizens to support their excellent schools."* The panel's full report can be accessed on the school district website at: <http://www.tallmadge.k12.oh.us/>

Also on the ballot this November, will be **three Board of Education seats**. Current Board President, Thom Craig, will not be running for re-election this November. Craig, a member of the Board for the past decade and President for the last 8 years, will end his tenure at the end of this current term (12-31-09). Vice President, **Valorie Prulhiere** will be seeking re-election as will board member **Rick Kellar**. Newly seeking a seat on the board is **Brad Croskey**, the district's former director of technology, who retired from the district August 1st of this year.

2010 CENSUS: A TOWN HALL MEETING

Town Hall Purpose and Goal:

- To *educate* and *inform* residents on the 2010 U. S. Census
- Share the Census history
- Share reasons why this process is *vital* to our areas (Tallmadge & Summit Co.)
- Encourage all residents are *counted* and *participate* with needed information

Answer questions:

- What happens with the Census information that is gathered?
- When and why '*redistricting*' happens?
- How will redistricting affect **Tallmadge** and surrounding communities?
- What happens if we lose *representation* within our senate & legislative boundaries?
- What happens if we lose federal and state **money**?

DID YOU KNOW?

The census is mandated by Article II of the U.S. Constitution to provide fair and equitable representation and apportionment of resources. The first census was taken in 1790 by U.S. marshals on horseback and counted 3.9 million people. Census 2000 counted more than 281 million people.

ISSUE 4: PROPOSED AMENDMENT TO SUMMIT COUNTY CHARTER

A majority affirmative vote is necessary for passage.

Shall the Charter of the county of Summit be amended to, effective January 1, 2013, consolidate and transfer the powers and duties of the County engineer to the County executive, who shall be required to employ a supervising engineer and a sufficient number of registered professional engineers and registered professional surveyors and to eliminate the office of County engineer in 2013 and the election for that office in 2012?

LEAGUE EXPLANATION: This amendment, if approved, would change the office of County Engineer from an elected office to a position appointed by the County Executive, effective January 1, 2013.

Arguments in favor of the amendment:

1. Those who are responsible for setting policy should be elected; those who are responsible for implementing policy should be appointed.
2. The consolidation of the two offices saves money and provides a more efficient and streamlined government.
3. Ohio is the only state in the United States that elects County Engineers.

Arguments opposed to the amendment:

1. Election of the County engineer ensures accountability to the voters
2. Townships need an elected engineer and the move would consolidate too much power in the hands of the County Executive.
3. If voters defeated this issue in 1006 and 2001, why bring it to the voters again?

League of Women Voters of Ohio Take Positions on 2009 State Ballot Issues

In analyzing proposed constitutional amendments, the League of Women Voters of Ohio begins with consideration of **whether** the proposed constitutional amendments properly belong in the Ohio Constitution or more properly should be legislated by the General Assembly. LWV-Ohio does not believe the Constitution should be littered with post-it notes®. Rather, LWV-Ohio's position on the Constitution, adopted in 1968, is that *"a constitution should be a clearly stated body of fundamental principles. It should provide for the flexible operation of government and be logically organized and internally consistent."*

Passage of Issue 1 would amend the Ohio Constitution to provide additional compensation to veterans of the Persian Gulf, Afghanistan and Iraq conflicts. Bonding authority that lasts longer than 2 years as in the proposed amendment must be set forth in the Constitution. However, the LWV-Ohio has no position under which to take action on the issue of providing additional compensation to veterans. **Therefore, the Board voted to take a NEUTRAL stance.**

Passage of Issue 2 would amend the Ohio Constitution to create the Ohio Livestock Standards Board. The amendment contains too much specificity to be in the Ohio Constitution and therefore, the **League's opposition is based on its state position that the Ohio Constitution should be a clearly stated body of fundamental principles.**

Passage of Issue 3 would authorize a casino in Cincinnati, Columbus, Cleveland, and Toledo. The LWV-Ohio board voted to **OPPOSE passage of Issue 3** for the same reason it opposes Issue 2; the proposed casino amendment contains too much specificity to be included in the Ohio Constitution. In addition, Issue 3 violates the state League's position that the legislature should have flexibility in financing state programs, because the amendment directs how the tax revenues will be allocated.
