imPACT – Political Accountability for Citizens Today is one of the largest political projects undertaken by the League of Women Voters of Ohio Education Fund. It is an initiative which started with a grant application from the Joyce Foundation (out of Chicago) that helps with efforts towards public policies and improving our quality of life in the Great Lakes region.

imPACT will provide the speakers and the forum for discussion, but we need our Tallmadge LWV members, family and friends to attend. Mark your calendar and plan to attend an informative evening on November 19th. I hope to see you there!

Regionalism to Improve Northeast Ohio

Lynda Mayer will discuss how regional tax-base revenue sharing and intergovernmental collaborative agreements reduce costs, foster transparency and accountability, improve efficiencies and maintain service standards. This presentation on February 18, 2010 will provide an update on the much-anticipated **Regional Prosperity Initiative**, the unprecedented effort coordinated by Northeast Ohio Mayors and Managers toward government reform at the municipal, county and regional levels.

On the State and National Front

From National: The League recently released a statement urging Congress and the President not to succumb to the bullying tactics of special interest groups, and continue supporting the public option included in H.R. 3200, [America's Affordable Health Choices Act of 2009](#).

From LWV Ohio: In 2005, [LWV-Ohio](#) sued the state regarding eight specific areas of concern relating to fundamental voting rights and equality of access to the polls. The goals of the lawsuit were met this summer as the parties reached a landmark settlement agreement to ensure uniformity and consistency in Ohio election procedures statewide, to promote pre-election planning to minimize errors and breakdowns such as occurred in previous elections due to lack of personnel and adequate equipment; training and recruitment of pollworkers; data collection and monitoring. The Secretary of State will have to report findings as they relate to two of the 8 areas: creating a statewide voter database and why provisional ballots were not counted in 2008 and what efforts will be made to prevent this happening in the future.

Meet the New Fire Chief at Salad Supper

Patrick Gaffney became the City's new Fire Chief on July 13th of this year. He has 27 years of experience with the department and has a degree in fire protection technology from the University of Akron. He started his career as an on-call firefighter and paramedic in 1976. He was selected from a field of 20 applicants for the position and according to Mayor Grimm, *"we interviewed a lot of applicants, some from much larger cities around the state, but we found the best qualified person for the job right here. I am proud and honored to see Pat take over the department"*.

Pat has the distinction of becoming only the third full-time Fire Chief since the department was established. The other two chiefs were father and son, John Crossen (9 years) and Dennis Crossen (28 years).

Overseeing the testing and selection of his successor as Assistant Chief will be one of Pat's first responsibilities. Another priority will be working on plans for the construction of a larger, more efficient Fire Station #2 (at Six Corners) by 2011. Pat, his wife Patti and their two children, Emily and Ryan live on Ashmun Avenue.

Focus on National Park

There were 2.8 million visitors to the Cuyahoga Valley National Park in 2008, making it the sixth most-visited National Park in the U.S., right after Yellowstone which had 3 million visitors. The CVNP is Ohio's only National Park and will be the topic of the **League Meeting on March 18th, 2010**.

The National park system itself is the focus of a 12-hour, six-part PBS series by noted filmmaker Ken Burns titled *"The National Parks: America's Best Idea,"* airing locally beginning September 27th. See local listings for start times. Immediately following the first show on the 27th, the local Western Reserve PBS stations will show *"Generations"* – the story of the 35-year old Cuyahoga Valley National Park.

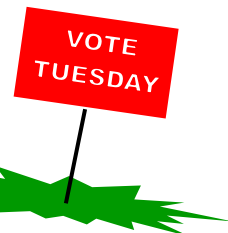
